### KENDALL SHOW GROUND TRADE EXHIBITORS

#### TERMS AND CONDITIONS

1. **LOCATION:** The event will be staged at the Kendall Show Ground, Batar Creek Rd, Kendall.
2. **DATES & TIMES:** The event will be open to the public on Saturday 9am start.
3. **INCLUSIONS:** All spaces rented are bare spaces. All entries to that space are to the exhibitors account and direction.
4. **ELECTRICITY/CONTRACTORS:** Only electrical contractors appointed by the organisers may run power or connect equipment with in the event. Power outlets will be available at sites where power has been requested and paid for in the rental agreement. **Any exhibitor intending to bring electrical equipment to the event will be requested to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor.** This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of the Occupational Health and Safety Act 1983. The Act imposes severe penalties in the event of non-compliance with its provisions. Any exhibitor who does not comply will not be allowed to exhibit at the Showground to avoid the occurrence of any difficulties.
5. **AUTHORITY:** The Exhibitor agrees to accept all requests and directions made by the organisers at all times.
6. **PAYMENT:** Unless specifically authorised in writing, NO Exhibitor may occupy the rented space unless full payment have been made at the given date. This includes delivery of goods, attendance by contractors or any activity on the contracted area.
7. **SETTING UP & DISMANTLING:** The grounds and buildings will be available for setting up from 9am to 3pm on Friday prior to the event. **All stands are to be completed by 8am on Saturday.** Dismantling is not to be commenced before 5pm on Saturday.
8. **RESPONSIBILITY:** Whilst all care will be taken, the Organiser accepts no responsibility for security of Exhibitor's goods or materials on site at any time. Insurances of all types, including Public Liability on the Exhibitor's display area, are the responsibility of the Exhibitor.
9. **INSURANCE:** Please provide copy of your current Public Liability (\$10M) insurance coverage. Interim cover is obtainable through the organisers at a cost of \$20 for the event.
10. **PARKING:** Exhibitor's vehicles not inseparable from actual trade spaces must be parked in designated parking areas and must abide by directions given by traffic directors at the manned gates and barriers.
11. **DISCLAIMER:** The organiser is specifically absolved by the agreement from responsibility for any claim for loss or damages or reimbursement or for any other entitlement dur to cancellation, failure to perform or any other reason or cause which is beyond the control of the organiser, including weather, industrial action, riots or acts of war.
12. **FUTURE RULES:** Further detailed regulations and conditions may be circulated to Exhibitors from time to time and will be considered part of the agreement.
